## **DETECTIVE DIVISION SUMMARY**

**May 2022**

In the month of May 2022, the Detective Division continued to investigate ongoing cases from previous months as well as new reported incidents. The information below highlights some of those events from May of 2022.

- Detectives on May 5<sup>th</sup> made an arrest related to a March 28<sup>th</sup> bank robbery at Glens Falls National Bank on Broad Street. Arrested was 34 year old Joseph Skellie of Glens Falls. Skellie was arrested and charged with Robbery 3<sup>rd</sup> Degree (Class D Felony) and Grand Larceny 2<sup>nd</sup> (Class C Felony). Skellie was also charged by police from Vermont with unrelated crimes that occurred after the bank robbery in Vermont as well. Detectives executed several search warrants in the investigation which led to significant evidence being discovered related to the incident.
- Detectives arrested a 55 year old Hudson Falls woman on charges related to bank fraud. The woman was charged with 2 counts of Petit Larceny (A Misdemeanor) and 3 counts of Possession of a Forged Instrument 2<sup>nd</sup> Degree (Class D Felony). The woman is accused of forging checks in another person's name and passing the checks in Glens Falls.
- Detectives are currently conducting backgrounds for employment with the agency. Four background investigations have been conducted for the position of Police Officer with the agency. Additional candidates are being interviewed and additional backgrounds may be conducted.
- In mid-May Detectives conducted a Criminal Interdiction Detail in conjunction with the Warren County Sheriffs Office, New York State Police, New York State Parole and Warren County Probation. Glens Falls Detectives and Officers conducted their portion of the detail in Glens Falls while other agencies worked in the surrounding area and Warren County. Seven

individuals were arrested by the Glens Falls Police Department as a result of the detail for the following: 4 for warrants, 3 for Criminal Possession of Controlled Substances and 1 for Criminal Impersonation. Also, a confidential informant was cultivated, and a controlled purchase of narcotics was conducted with the Warren County Sheriffs Office.

- Detectives are currently investigating an online scheme to defraud case. The victim of the case was defrauded into investing approximately \$330,000 into an online scheme. Detectives are currently investigating the fraud as well as working with the FBI as the case and suspects involved expands outside of Glens Falls.
- Detective Hogan has completed his training and has become a certified Crime Scene Evidence Technician. The training certifies him to process crime scenes as well as process evidence amongst other things evidence related. Obtaining this training expands the divisions coverage as all Detectives are now trained Crime Scene Evidence Technicians.
